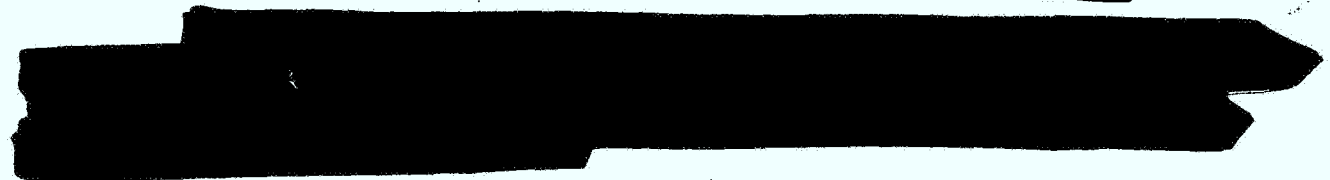

I pass the following information along to you in the thought that it has security aspects which cannot be overlooked.

On Tuesday evening, July 29, I was dining with a friend of mine

at a restaurant called Peter's Back Yard, on West 10th Street in New York City. At the next table a man was dining alone--or rather drinking, and getting perceptibly drunk. At last he interrupted our conversation and introduced himself as

evidently on detached duty from that institution. Because of the liquor, his remarks were slightly disjointed, but what follows represents a careful summary of his main assertions. I made notes shortly afterwards, on which I am now basing this report.

conversation (and he is a compulsive talker, at least when drunk) varied abruptly between routine denunciations of Khrushchev, plus loud, unconvincing assertions that we must "draw the line" against Soviet aggression, and an incredible hash of crypto-Communist propaganda. Along the latter line, I noted down after dinner the following items:

- 1) The great evil in the world today is John Foster Dulles and his "moralistic diplomacy." For instance, he explained, it is absurd to say that Chiang should be on the mainland of China, when in fact the peasants are better off under Mao.

Translation from the Estonian

Valismaalaste Silmadega (translation - Through the Eyes of Foreigners). The sub-title which appears in parenthesis can roughly be translated to mean: The opinions of visitors to the USSR. The booklet was published in 1958 by the Committee for "Returning to the Homeland." It was printed by "Uhiselu" (translation - "Community Life"), Tallinn.

Pages 3 - 13. Introduction (full translation). The introduction was written by I. TURBAI.

Predictions that Have Failed to Materialize

(In place of an introduction)

"The common Spaniards turned to me, as a person who has lived in the Soviet Union nearly 20 years, with questions about the socialistic country and its people. And what questions were presented to me! For instance I was asked: 'Is it true that grownups eat children in Soviet Russia? Is it true that the worker in Russia receives a certain number of ? instead of money and that working people cannot eat at home but are required to dine in a restaurant.' Your hair stands on end when you hear such questions. And in the Twentieth century!"

Thus wrote about his trip to Spain ROCHINEZ-GARAISAR JOSE MARIO, whose letter we published recently in the newspaper "For Returning to the Homeland".

It is natural that as an honest person JOSE MARIO, who was brought to our country as a child and grew up in the actual conditions of the Soviet Union, had to feel deep displeasure over the dirty propaganda which is directed towards the country which has become his second homeland.

"You see now how far has gone the Fascist slander in Spain towards the workers' and farmers' country," shouts JOSE MARIO. Young JOSE could be surprised and get angry at this gloomy fiction, as if grownups would eat children in our country. But the older generation of the Soviet Union and even the generation of the October Revolution have heard even worse.

[REDACTED] Congressman CLAUDE PEPPER, Miami, Florida, on July 15, 1968, advised [REDACTED] Miami, Florida, had visited the Congressman's office to discuss her planned departure from the United States. [REDACTED] stated she had a fourth grade education, but later remarked she was a scientist and a writer. [REDACTED] related she was to meet with WERNER von BRAUN to work with him at the United States Space Laboratory, but that he "kicked her and forced her out of his office." [REDACTED] also mentioned she had been attacked and beaten by several men. [REDACTED] advised [REDACTED] impressed her as an individual with some type of mental problem.

A first source, on July 24, 1968, advised that [REDACTED] had visited her on the evening of July 23, 1968. [REDACTED] requested assistance in delivering to WERNER von BRAUN information on three landing areas on the moon. The source stated she believes [REDACTED] to be a "mental case," who needs treatment.

A second source, another government agency which conducts intelligence investigations, on August 26, 1968, advised that [REDACTED] who had requested removal to Paris on two occasions, failed to depart the United States after arrangements had been made for her departure by the sponsor through the American Red Cross. On one occasion, she refused to fly, claiming a heart condition and the fact that her books amounted to 200 pounds of excess luggage. Arrangements were then made by the sponsor for sea travel, which [REDACTED] again failed to take advantage of. According

Translated excerpts from a letter addressed to Dr. Werner von Braun, Director of the George C. Marshall Space Flight Center, NASA, are forwarded as a matter of possible interest to your agency. The letter, written March 21, 1964 by Walter Hecker, 14010 Castalia Avenue, Cleveland, Ohio, alleges that a manuscript of the book, "The Secret of Huntsville," by Julius Mader, an East German author, was submitted to Dr. Gustav Kuerti of Case Institute, Cleveland, Ohio, for review prior to publication. The excerpts are as follows:

"Around New Year I visited Germany and met Professor Oberth who asked me to give you his very best regards. Our conversation also turned to the book of a certain Julius Mader, which may be called the most evil piece of Soviet hate campaign directed against your person. The defaming statements that it includes, have started an exchange of correspondence between the German Museum in Munich and Mader and also between Professor Oberth and Mr. Poehlmann. Professor Oberth gave me copies of this correspondence. I also am in possession of the questionable book.

Although it is more or less a waste of time to do anything about the book, its contents should nevertheless not be accepted without rebuttal, since it is damaging to you and indirectly to the entire free world. Personally I am considering the book a part of the political scheme of the Soviets to prevent the U.S. (and the free world) from being first on the Moon." ..

"The matter is also somewhat delicate insofar as for these dark machinations - willingly or unwillingly - helpers are found even in this country. Through my connections with the Case Institute, I already heard last year that the manuscript of the a/m book was submitted for review before publication to Professor Dr. Gustav Kuerti. Apparently he served as lector. But enough of this disgusting matter."

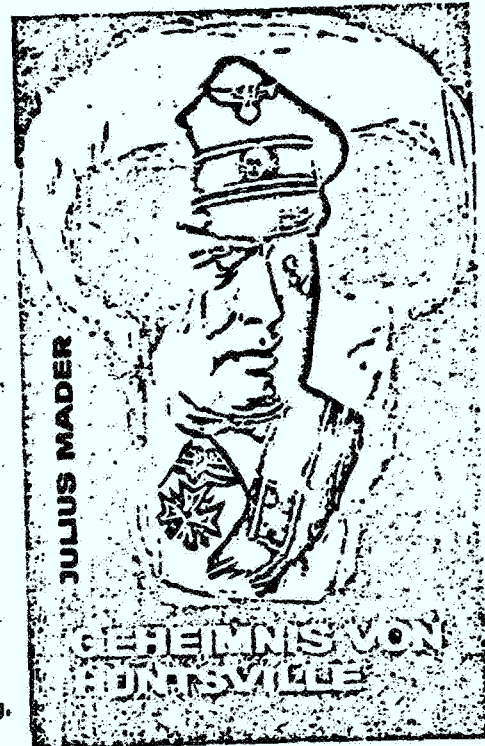

Not so long ago, this sleepy little village, nestled into the red fertile soil, belonged entirely to the domain of King Cotton. In the lost little hamlet, far away from the hubbub of the big world, the white planter aristocracy has been ruling over colored farm hands who vegetated in their shabby shacks.

But normal country living stopped more than a decade ago. Within several dozens of months, the population quadrupled to over 60,000 persons. On the new highway 231 a stream of rolling cars is proceeding continuously. Planes,

landing in quick succession on the City - County Airport or taking off from the strips of the adjacent military airport, break the sound barrier just above the center of town. New supermarkets are offering their confusing display of merchandise with blaring advertisements. Souvenir shops find plenty of customers. Three hotels and 21 motor courts, typical accommodations for U.S. motorists, have "sprung up" from the ground. Many plantation owners turned their farmland into dollars and are devoting their efforts to more promising fields. They are draining the pocketbooks of the soldiers who are dominating the city streets.

Huntsville has been rocked by a fever, ever since rocketry and prosperity entered this town near the northern boundary of the Southern State of Alabama. Daily, sometimes every hour, a thunderous roaring emanates from the southwestern part of the city. Out of cascades of yellow flames and darkbrown smoke, slender projectiles emerge into the air and turn toward the south against the usually cloudless sky. Vapor trails are glued to the firmament, but only attract the attention of strangers.

Quite often, emergency cars of the police, followed by ambulances, stop the hectic city traffic with sirens and blue lights. Behind the gates of the Huntsville Hospital, the cauterized and scorched disappear. The residents of Huntsville are used to such incidents. Risk is part of their business and the motto "time is money" stops them from spending too much of their time on the human problems of American rocketry. Occasionally, they check with their most intimate circle of friends whether the tank explosion or the unsuccessful launch has left any vacancies in the usual party crowd so that other arrangements can be made in time.

Much has changed in Huntsville, also the name of the hill north of the Monte Sano, which now bears the name - quite unfamiliar to this region - of Sauerkraut Hill. A subdivision of comfortable homes surrounds this area. In one of the luxurious mansions a baron resides. The house is surrounded by climbing rose bushes which are laboriously taken care of by domestic gardeners. The baron considers himself the uncrowned ruler not only of the Sauerkraut Hill, but of an even greater empire; because with him an unprecedented business upswing entered the remote rural community. Nevertheless, he always drives his Chrysler himself. Each year a new model. It is not far to his place of work, just a few miles.

Quite often, news hunting reporters try to stop him on his way. But when the iron gates are zealously opened and closed again at the end of his trip, he finally gets rid of them. On reserved territory, the broad-shouldered baron hurries to his offices in a yellow, long-stretched and, of course, air-conditioned tract. The guard at the entrance always enjoys the matutinal jovial greeting. But then the door of the room 4488 closes. The secretary, a black-haired blond, presents her boss the daily schedules. On his mahogany desk, signature folders, drawings, and complex calculations are piling up. The locked safe almost ~~it~~ spills over with highly secret documents. As a rule, the entire building soon knows in what mood the boss of four thousand nine hundred technicians and development engineers is.

A Prussian Junker pursues his career as an American upstart. His name is familiar in the western world: Werner Baron von Braun.

In fact, the Baron well succeeded to americanize his retinue. His worries about bodyguards are taken care of by the ^{the} American government. Instead of coachmen and grooms, who were at his father's services by the dozens, he
